It is for the information of the students that the Punjab Technical University has announced "PTU Free Ship Scheme" for students of weaker section Society. The students belonging to following categories can apply for PTU-Free Ship Scheme for financial assistance :-

- (1) Parent Less Students : Eligible for financial assistance for full free ship of fee, if the total family income of the student is less than Rs. 2.50 Lakh from all sources.
- (2) Father Less Students : Eligible for financial assistance for half free ship, if the total family income of the student is less than 2.50 lakh from all sources. In case the income of concerned is less than 1.20 lakh then he / she shall be eligible for financial assistance for full free ship.
- (3) Low Income Group Students : Eligible for financial assistance for half free ship, if the total family income is less than Rs. 2.50 lakh from all sources. In case the total family income is less than Rs. 1.20 lakh then he / she shall be eligible for financial assistance for full free ship.

The Performa for Financial Assistance is displayed alongwith this Notice on the Notice Board. Students Interested for availing above financial assistance from the Punjab Technical University are hereby instructed to fill the performa and submit to the Students Section latest by **25.08.2011** alongwith 10th class Certificate, Income Certificate, Affidavit of Income duly attested by MC/Sarpanch and Notary.

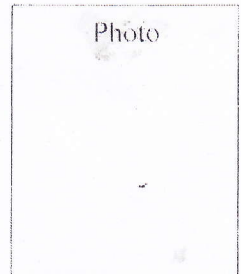
